# Open letter from facebook on April 5, 2022

Good day High Commissioner for Human Rights, Mrs. M. Bachelet Jeria. I have informed you that several open messages have been released here. You still do not answer and you do nothing. The open messages here, including those to the Dutch parliament, the Government and also to the Dutch judiciary, are evidence that solely the civil service only speaks the language of violence. Ignoring ALWAYS escalates and war is the final stage. This can be verified in history. One of the two belligerent presidents said one time that peace can only come if he comes into direct conversation with the other president. The civil service immediately prevented this and after one time nothing more was heard from him about this. Punishments have been imposed on one fighting party by officials from 'the west'. #### Open letter from facebook on March 6, 2022

Good day High Commissioner for Human Rights, Mrs. M. Bachelet Jeria. I have let you know that this open message is published here, because at last there is a war in Ukraine. You were personally warned about this on January 21, 2020. The response was icy silence and doing nothing. War NEVER happens suddenly. The power in the injustice economy has been copied in international tribunals. For years it is complained that Peace Palaces, International Courts and National Courts have become political institutions. The Council of Europe recently stated its intention to act as co-legislator through national judiciary. Due to the lack of "Fair Play" and justice, (for example) Russia is taking its own measures.
